## HARI Temple Scholarship

2019

The HARI Temple Scholarship has been established to provide scholarships to deserving high school seniors throughout central Pennsylvania for the purpose of advancing their education.

A selection committee composed of Public Relation Officer and his/her nominees, who will act in cooperation with the other designated HARI Temple Members, will choose the scholarship recipient or recipients based on the information supplied by the applicants.

Only those applications received on or before **April 28, 2019** will be considered.

In determining the recipient or recipients, the committee will evaluate applicants by the following criteria:

- **Scholastic Ability** must meet minimum academic standard of **3.0** during high school based on a 4 point scale. (A=4, B=3, C=2, D=1, F=0)
  - o Transcripts Include up to and including second marking period -OR- student record up to and including December of their Senior Year
  - o GPA will be the primary consideration
  - o In the event GPA ties for two or more students, SAT score will be considered as a secondary criteria
  - o In the event both GPA and SAT tie for two or more students, due considerations will be given to HARI School students and/or HARI volunteers
- Permanent Resident or Citizen of United States.
- HARI Temple member for past 2 years (either the applicant or parents).
- **Special Requirements:**
  - o Please provide a copy of your college/school Letter of Acceptance to go along with your Scholarship application.
  - o Your applications will not be accepted without a copy of this letter!
- Must write a personal statement explaining why you deserve this scholarship and how you plan to use it.
- Form B must be completed giving details of your participation for each question
- \* Financial Information.

It will be necessary for applicants to submit proof satisfactory to the committee of their admission to a duly accredited institution of post-high education, including, but not limited to, 4 year colleges, 2 year colleges, vocational-technical schools, trade schools, nursing schools and other colleges.

All information supplied by applicants will be considered strictly confidential, and under no circumstances shall the committee take into consideration the sex, race or religious background of the applicants.
